Release and Waiver: In consideration for being permitted to participate in the said project, I hereby release and forever discharge Delek Children Foundation and its director, volunteers and staff from any and all claims, liability, injuries, losses, damages, or costs of any kind or nature that arise from, are caused by, or are related in any way from my activities with Delek Children Foundation. I understand that his Release and Waiver discharges Delek Children Foundation from any liability or claim that I may have against Delek Children Foundation with respect to bodily injury, personal injury or property damages that may result from my activities with the said project. I also understand that Delek Children Foundation does not assume any responsibility for or obligation to provide financial or other assistance, including but not limited to medical, health, auto or disability insurance in the event of injury or loss.
